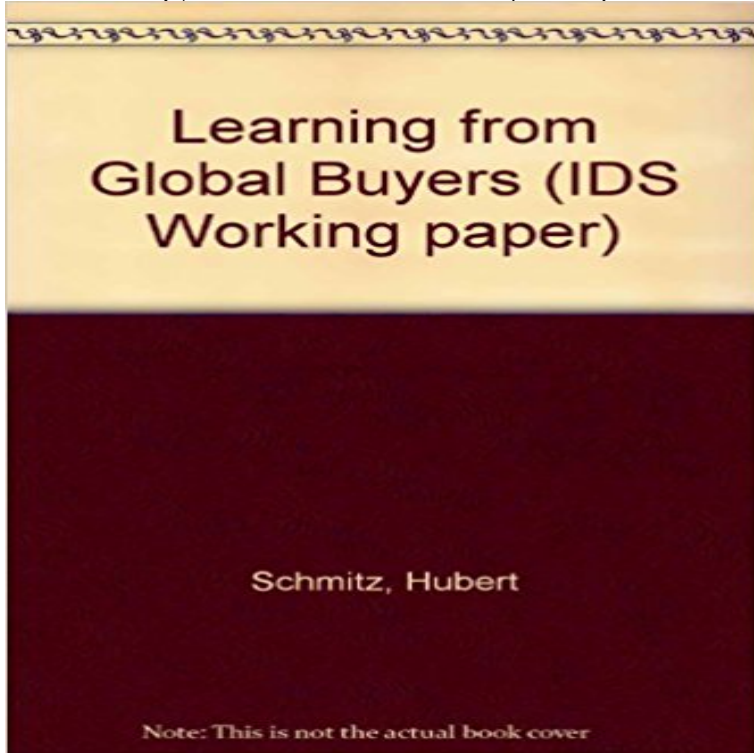


Learning from Global Buyers (IDS Working paper)
