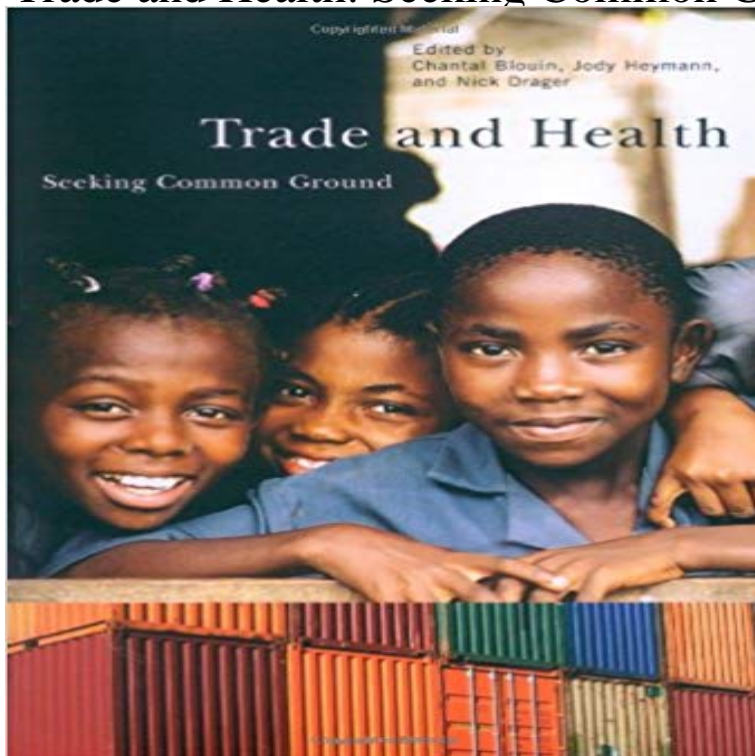


## Trade and Health: Seeking Common Ground
