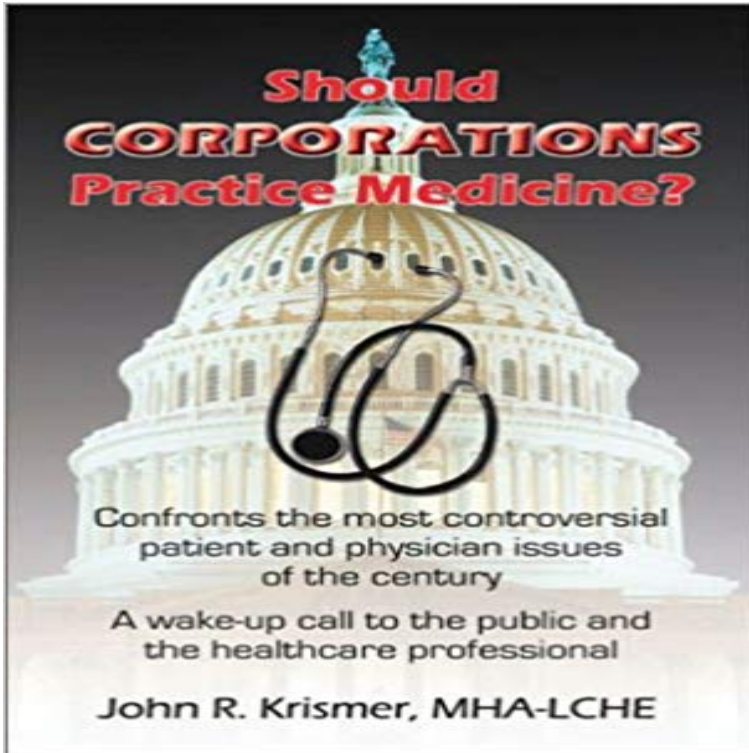

The 1910 Flexner Report warned us about advertising, competition, and money incentives, saying: ...promotion of medicine as a business, rather than an ethical profession, resulted in the general interest of the public being lost. *Should Corporations Practice Medicine?* suggests a more humanistic practice of medicine that's performed by professionally licensed specialists; but only if organized medicine can or will assume the professional leadership required.
