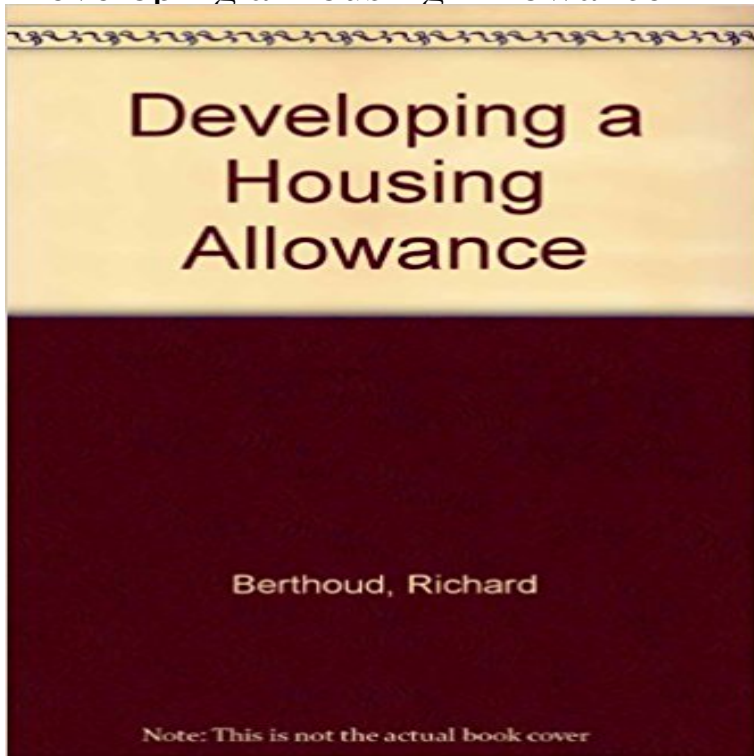


Developing a Housing Allowance
